1. On your smartphone, tap the Accept Tickets button above.  
The tickets will be emailed to you and will be in your Ticketmaster account.
  2. Sign in with your Republic of Ireland account, or create one, to accept your tickets. (The email and password for your Republic of Ireland account may be different from your Ticketmaster account.)
  3. Keep an eye out for a follow-up email with instructions on how to view and save your tickets for the big day.
