

Booker Rockstar Win Cash Prizes

TERMS & CONDITIONS

1. INTRODUCTION

These Terms and Conditions prevail in the event of any conflict or inconsistency with any other communications, including advertising or promotional materials. Entry instructions are deemed to form part of the Terms and Conditions and by participating, all entrants will be deemed to have accepted and be bound by the Terms and Conditions. Please retain a copy for your information.

2. THE PROMOTER

Britvic Soft Drinks Ltd, Breakspear Park, Breakspear Way, Hemel Hempstead, Herts, HP2 4TZ. Registered in England No. 517211.

3. ELIGIBILITY

The promotion is open to residents of GB (England, Wales and Scotland) aged 18 years or over only who have a valid and active Booker account, except:

- (a) employees of the Promoter or its holding or subsidiary companies.
- (b) employees of agents or suppliers of the Promoter or its holding or subsidiary companies, who are professionally connected with the promotion or its administration; or
- (c) members of the immediate families or households of (a) and (b) above.

4. THE PROMOTION

- 4.1. The title of the promotion is 'Booker Rockstar Win Cash Prizes'.
- 4.2. The promotional period will open at 12:00am on 02/06/2021 (the "**Opening Date**") to 23:59 on 07/07/2021 (the "**Closing Date**") inclusive (the "**Promotion Period**"). All promotion entries received before or after the Closing Date are automatically disqualified.
- 4.3. Purchase of promotional products listed in clause 5.5 below on www.Booker.co.uk is necessary to participate in the promotion. Internet access required.
- 4.4. To enter prize draw, participants must have a valid and active Booker account and buy the promotional Rockstar products in one transaction on www.Booker.co.uk during the Promotional Period to be automatically entered into the prize draw.
- 4.5. Three of the following promotional products must be purchased to enter:

- 4.6. Maximum of one (1) entry per person per Booker account, during the Promotional Period.
- 4.7. Entrants who do not enter correct details will be disqualified, at the Promoter's discretion.
- 4.8. Proof of sending or placing an order will not be accepted as proof of delivery or receipt of entry. Incomplete, illegal, misdirected or late entries will not be accepted. The Promoter takes no responsibility for entries delayed or lost due to technical reasons or otherwise.

5. THE PRIZE

- 5.1. There is 1 x £5000 cash prize to be won and 10 x £100 cash prizes to be won in total, one cash prize per winner. Each prize will be awarded directly to the entrant and not their employers. If an entrant is no longer an employee of the account holding business at the time of the Draw Date, they will remain eligible to receive the prize subject to verification.
- 5.2. Upon drawing the 11 winners, the first drawn winner will receive £5000 and the following 10 winners will receive £100. The cash prize will be in the form of a bank transfer payment or cheque to a GB bank account. Any cheque must be cashed 6 months from the written date.

6. WINNER SELECTION AND NOTIFICATION

- 6.1. All 11 winners will be selected via a randomised computer process from all valid entries received during the Promotional Period on 08.07.2021 (the "Draw Date").
- 6.2. Winners will be notified via a phone call using the telephone number associated with their Booker account used to purchase the promotional products to enter the promotion. Winners will be asked to confirm prize acceptance and provide their full name (as it appears on their bank account) and delivery address. Alternatively, winners can provide their full name, bank account number and sort code for a bank transfer to be made.

- 6.3.** Three attempts will be made to contact each winner via phone call over a 14-working day period starting from 09.07.2021. Winners have 48 hours from 3rd attempt on 29.07.2021 to confirm acceptance of their Prize, otherwise the Promoter reserves the right to offer the prize to the next eligible entrant selected from the correct entries that were received before the Closing Date using the same methodology as described in clause 7.2. Attempts to contact winners will be made throughout the day between 09:00 and 17:30. A voicemail will be left if possible, which winners will need to respond to within 48 hours from the 2nd attempt. Entrants are encouraged to monitor their connections during this time in case they are the winner.
- 6.4.** The Promoter does not accept any responsibility in the event a winner is not able to take up their prize, rejects the prize or are ineligible and reserves the right to offer the prize to the next eligible entrant selected from the correct entries that were received before the Closing Date using the same methodology as described in clause 7.2. The process will repeat for a period of 3 months following the Closing Date until an eligible winner is able to claim the prize. Following this 3-month period, all remaining prizes will become null and void.

- 7.1.** Please allow 30 working days from valid acceptance and the completion of any verification process for delivery of the Prizes. Cheques will be delivered via registered post. A signature will be required to acknowledge delivery.
- 7.2.** If delivery will be delayed due to the Covid-19 pandemic and resulting Government restrictions all winners affected will be contacted by the Promoter and kept updated of any unavoidable changes and revised delivery dates.
- 7.3.** If any Prizes are undelivered due to inaccurate details the Promoter reserves the right to withdraw and reallocate the prize entitlement with no liability.

8. LIMITATION OF LIABILITY
