Short Terms and Conditions:

Open to ROI & NI residents aged 18+. Internet access, email address and smartphone with camera required. To enter the prize draw scan the QR code using your phone camera or visit https://energiseballygowantickets.ie/ & enter your details. Promotional period: 1st July – 31st October 2025.
