#### **1. THE PROMOTER**

Britvic Soft Drinks Ltd, Breakspear Park, Breakspear Way, Hemel Hempstead, Herts, HP2 4TZ. Registered in England No. 517211.

## 2. ELIGIBILITY

The promotion is open to residents of the UK (England, Wales, Scotland and Northern Ireland)], aged 16 years or over only, except:

(a) employees of the Promoter or its holding or subsidiary companies;
