

FULL TERMS & CONDITIONS

1. These Terms and Conditions prevail in the event of any conflict or inconsistency with any other communications, including advertising or promotional materials. Claim instructions are deemed to form part of the Terms and Conditions and by participating, all claimants will be deemed to have accepted and be bound by the Terms and Conditions. 2. THE PROMOTER

3. ELIGIBILITY

The promotion is open to residents of the Great Britain (England, Wales and Scotland) aged 18 years or over only, except:
