TERMS & CONDITIONS

1. INTRODUCTION

These Terms and Conditions prevail in the event of any conflict or inconsistency with any other communications, including advertising or promotional materials. Entry instructions are deemed to form part of the Terms and Conditions and by participating, all entrants will be deemed to have accepted and be bound by the Terms and Conditions. 2. THE PROMOTER

4. ELIGIBILITY

The promotion is open to residents of GB (England, Wales and Scotland) aged 18 years or over only who work for a company with a valid and active Booker account, except:

- (a) employees of the Promoter or its holding or subsidiary companies.
- (b) employees of agents or suppliers of the Promoter or its holding or subsidiary companies, who are professionally connected with the promotion or its administration; or
- (c) members of the immediate families or households of (a) and (b) above.

5. THE PROMOTION

- 5.1. The title of the promotion is 'Booker Robinsons Win Cash Prizes'.
- 5.2. The promotional period will open at 12:00 on 31/03/2021 (the "**Opening Date**") to 23:59 on 04/05/2021 (the "**Closing Date**") inclusive (the "**Promotion Period**"). All promotion entries received after the Closing Date are automatically disqualified.
- 5.3. Purchase of promotional products on Booker.co.uk is necessary to participate in the promotion. Internet access required.
- 5.4. To enter prize draw, participants must have a valid and active Booker account and buy the promotional Robinsons products listed in clause 5.5 below in one transaction on Booker.co.uk during the Promotional Period to be automatically entered into the prize draw.
- 5.5. The following promotional products must be purchased to enter:

AND

2 cases (6 x 1L) of Robinsons Fruit Creations 1L (any flavour)

- 5.8. Proof of sending will not be accepted as proof of delivery or receipt of entry. Incomplete, illegal, misdirected or late entries will not be accepted. The Promoter takes no responsibility for entries delayed or lost due to technical reasons or otherwise.

6. THE PRIZE

7. WINNER SELECTION AND NOTIFICATION

- 7.1. All 10 winners will be selected via a randomised computer process from all valid entries received during the Promotional Period on 05.05.2021 (the "Draw Date").
- 7.2. Winners will be notified via the telephone number associated with their Booker account used to purchase the promotional products to enter the promotion. Winners will be asked to confirm prize acceptance and provide their full name (as it appears on their bank account and delivery address).
- 7.3. Two attempts will be made to contact each winner via phone call over a 14-working day period starting from 06.05.2021. Winners have 48 hours from 2nd attempt on 20.05.2021 to confirm acceptance of their Prize, otherwise the Promoter reserves the right to offer the prize to the next eligible entrant selected from the correct entries that were received before the Closing Date using the same methodology as described in clause 7.2. A voicemail will be left if possible, which winners will need to respond to within 48 hours from the 2nd attempt. Entrants are encouraged to monitor their connections during this time in case they are the winner.
- 7.4. The Promoter does not accept any responsibility in the event a winner is not able to take up their prize, rejects the prize or are ineligible and reserves the right to offer the prize to the next eligible entrant selected from the correct entries that were received before the Closing Date using the same methodology as described in

- 8.2. If delivery will be delayed due to the Covid-19 pandemic and resulting Government restrictions all winners affected will be contacted by the Promoter and kept updated of any unavoidable changes and revised delivery dates.
- 8.3. If any Prizes are undelivered due to inaccurate details the Promoter reserves the right to withdraw and reallocate the prize entitlement with no liability.

9. LIMITATION OF LIABILITY

- 9.1.
