

MiWadi Trick or Treat Terms and Conditions

Submit your bid via the comments section under the auction post on this Instagram page @miwadi_ireland

Full terms:

- 1. This auction is only open to legal residents of the Republic of Ireland who are aged 18 or over, excluding employees of the Promoter or anyone else professionally associated with this auction.
- 2. This is an auction run in aid of raising funds for charity. Internet access and a valid Instagram account is required. Successful bidders will be required to complete their charity donation to Children's Health Ireland Trick for Treat for Sick Children campaign (CHY 13534 RCN 20042462) in order to receive their purchase of the piece of Chris Judge artwork detailed in the relevant Instagram post.
- 3. **Auction Period:** You can enter between 12.00noon and 8.59pm GMT on the following 4 Fridays in October 2021: 8th October, 15th October, 22nd October and 29th October 2021 (each an Auction Period).
- 4. There are 4 x original FruitMonsters illustrations, each a piece of artwork designed by the Irish artist Chris Judge available and one Auction Period per illustration. Artist and illustrator Chris Judge has been commissioned by MiWadi to create four bespoke digital FruitMonster artworks that will be available for purchase through a charity auction hosted on the MiWadi Ireland Instagram page. 100% of all proceeds will go to the Children's Health Ireland Trick or Treat for Sick Children campaign.
- 5. **Auction entry details:** Log into your Instagram account (or create one for free) and submit your bid in the comment section underneath the promotional post on the MiWadi Ireland Instagram page ONLY @miwadi_ireland during an Auction Period.

A promotional post for each illustration will be created and posted to the MiWadi Instagram feed on [08/10/2021, 12noon GMT], [15/10/2021, 12noon GMT], [22/10/2021, 12noon GMT] & [29/10/2021, 12noon GMT].

Bidding will open on one illustration at a time, as per the below schedule:

- Illustration 1: Bidding opens [08/10/2021, 12noon GMT] Bidding closes [08/10/2021, 8.59pm]
- Illustration 2: Bidding opens [15/10/2021, 12noon GMT Bidding closes [15/10/2021, 8.59pm]
- Illustration 3: Bidding opens [22/10/2021, 12noon GMT] Bidding closes [22/10/2021, 8.59pm]
- Illustration 4: Bidding opens [29/10/2021, 12noon GMT] Bidding closes [29/10/2021, 8.59pm]
- 6. The opening bid amount will start at €25. This is the least amount the art piece will sell for. All bids must be in EURO only and bids can increase in 5 euro increments.
- 7. Multiple bids are permitted during the Auction Period, but you may only purchase a maximum of 1 piece of art across the Auction Period.
- 8. BIDDER Selection:



Once bidding has closed, as per above schedule, the highest bidder at the time that bidding closes will be notified via direct message from the MiWadi Instagram page within 24 hours to confirm you are the successful bidder

- 9. **Successful Bid Notification:** The highest bidder will then have 24 hours to confirm their bid, make a donation of the bidding amount to www.childrenshealth.ie/trickortreat and submit evidence of this donation to the Promoter via its Instagram page DM or email.
 - In the event that the highest bidder does not reply or decide to not go ahead with their donation, the next highest bidder will be contacted.
 - In the event that there are two or multiple identical bids at the time that bidding closes, the person who made the highest bid first would be selected as the winner.
- 10. The winner(s) will be contacted within 28 days of the acceptance of the Prize to organise the Prize.
- 11. By entering, you agree to allow the Promoter to use your name, and county of residence if selected as a purchaser, in making a Purchaser List available.
